

**OFFICIAL RULES**  
**“WIN YOUR OMNI -HEAT™ INFINITY JACKET” - ON-LINE PRIZE DRAW**

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR  
PAYMENT OF ANY KIND WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

1. **ELIGIBILITY:** This “Win your Omni-Heat™ Infinity Jacket” On-Line Prize Draw is open only to individuals who (a) are legal residents of Great Britain, France, Germany, Austria, Ireland, The Netherlands, Belgium, Spain, Italy or Finland (b) are at least eighteen (18) years of age at the time of entry, (c) and have access to the internet and a valid e-mail address. Employees or contractors of Sponsor, a competitor of Sponsor, or any of their affiliate companies, subsidiaries, agents, distributors, wholesalers, retailers, or advertising and promotional agencies, as well as the spouse, parents, siblings, children and household members of any such employee or contractor, are not eligible.

1 (one) Omni-Heat™ Infinity Jacket from the collection available on the local columbiasportswear e-commerce site (see clause 15).

The approximate retail value of the prize depends on the selected product by the winner but will not exceed 350€/£.

The **winner** will be drawn at random from all participants who have registered via the online prize-draw site listed below. There is a limit of one prize per person. Prizes are nontransferable until awarded and are non-refundable. No cash or other substitution may be made, except by Sponsor, who reserves the right to substitute a prize with another prize of equal or greater value if the prize is not available for any reason (e. g. out of stock, governmental restrictions etc.). Each participant agrees to disclose accurate information about themselves. Sponsor disclaims any responsibility in the event that a participant uses a false name and / or names associated with a valid email address or impersonates another person. 6. **WINNER SELECTION:** By entering this On-Line Prize Draw, you agree that Sponsor or its subsidiaries and affiliates and/or each of their representatives, employees, agents and contractors, together with an independent party as juror verify your entry. Within five (5) days following the conclusion of the Entry Period, an independent party will draw the potential winner from among all eligible entries. Sponsor's decision is final and no correspondence will be entered into. Sponsor will notify the potential winner by e-mail within ten (10) days. The publisher of the website is the company SEKOYA DIGITAL, which is responsible for the publication. The director for the publication of the website is Natacha ORDAS. The hosting of the website is provided by SEKOYA DIGITAL through the company Hosteur, whose registered office is located at 231 rue Saint Honoré, 75001 Paris

"Authorized Account Holder" means the natural person who is assigned to a particular username or e-mail address by an internet access provider, service provider, or other organization that is responsible for assigning e-mail addresses or usernames under the domain associated with the submitted e-mail address or username.
